

## **2018\_06\_04\_RLC Minutes**

**Roll Call** – The meeting began at 6:30 pm. The members present were Susan Koenig, Joann DiBella, Deb Dobransky, Bruce Hackett, Barry Phillips, Pat Zisa, Gene Tadlock, and Kathy Boyd. No new residents attended the meeting.

**Acceptance of Minutes** – The minutes from the May meeting were sent out to all members prior to tonight's meeting. Joanne moved the minutes be approved and Deb seconded. The minutes were approved.

**Current Events Fund Balance** – The previous balance was \$644.36. Proceeds from the wine tasting were \$15.62. General supplies purchased came to \$72.95. The current balance is \$587.03

**Review of Event – Wine Tasting**- This was held on May 18, 2018 and Ellen Grillo was the coordinator. Twenty six people bought tickets and there were two non-wine drinking spouses who attended. Ticket sales came to \$313 and expenses were \$297.38 and so the proceeds were \$15.62.

**Food Drive** - Deb Dobransky is the coordinator and she reported that the food drive has begun and will go through to the end of August. Deb will put out info regarding a service day. There was discussion about the sign and the committee felt it should remain in place until there is a ruling. Deb will contact Jonathan and the ARC committee regarding this issue.

**Adopt- a Highway** – Deb is also coordinating this activity. The second clean- up took place on June 2, 2018. Seventeen people participated. Area was from Kendale Rd, down Beaver Dam Rd to Hopkins Rd to intersection with Fisher Rd. People were interested in having another pancake breakfast after the next clean-up day which will be mid-end of September or early October.

**Pancake Breakfast** – This was held on June 2, 2018 and was sponsored by the clubhouse committee and the lifestyle committee supported this event. Susan told Barry that Jonathan had received the money to deposit and that this money is separate from the lifestyle account.
